Kankakee County—Offering frail, older adults and their families assistance as they assess the need for care and coordinate an overall plan of service to maximize the older person's independence in the home.

ADULT PROTECTIVE SERVICES

Kankakee & Grundy Counties—Providing trained and caring professionals to help determine the services most needed to stop neglect and abuse; protect the person who has suffered abuse and/ or neglect; and assist the individual in the healing process. Intervention for the abuser is also offered.

FOSTER GRANDPARENT PROGRAM

Will County—Offering adults age 55 and older an opportunity to mentor children at local elementary schools and pre-schools.

INFORMATION AND ASSISTANCE

Kankakee County—Providing information about and linkage to the many services and benefits available to older adults and persons with disabilities.

MONEY MANAGEMENT PROGRAM

Kankakee, Grundy, Iroquois & Will Counties—Providing information about and linkage to the many services and benefits available to older adults and persons with disabilities.

LONG-TERM CARE OMBUDSMAN

PROGRAM Grundy, Kankakee & Will Counties—Providing advocacy and support for residents in long-term care facilities. They act at the discretion of the resident to resolve his/her concerns or complaints.




Aging & Disability Services

Bennie Mae Gavin isn't an average 92 year old. While some of her peers may be slowing down a bit, she lives independently and volunteers 20 hours per week for Catholic Charities' Foster Grandparent program. This sweet and chatty senior calls everyone "honey" and is quick to share her favorite recipes for cornbread dressing and sweet potato pie.

Bennie Mae has been a widow for many years, and 27 years ago she was looking for a new and meaningful way to spend her time when her daughter, Carol, referred her to Catholic Charities' Foster Grand-parent Program. This was a great match for Bennie because she loves helping others and keeping busy.

Today, Bennie Mae is a daily volunteer as a foster grandparent at Trinity Services in Joliet, which is a non-profit organization that helps adults with developmental disabilities lead full and abundant lives. Bennie Mae helps the clients at Trinity Services with their daily activities, but she has also forged meaningful relationships with many individuals. "We laugh and talk," she says with a smile. "This program means a lot to me," Bennie Mae says of the Foster Grandparent Program. "It gets me out of the house each day. At my age, that's very important. Get up, get out. It's what keeps me alive."

Recently, Bennie Mae's outstanding efforts were recognized when she was a recipient of the prestigious Governor's Volunteer Services Awards for 2016. These awards honor volunteers through a statewide program to highlight the importance of volunteerism and community service in the State of Illinois. Bennie was recognized in the North East Senior Corps category for her work with Catholic Charities.





Counseling Services

COUNSELING SERVICES

DuPage, Ford, Grundy, Iroquois, Kankakee, Kendall & Will Counties.

Providing healing and hope through caring and effective behavioral health services. The diverse and professional therapists provide a wide range of therapeutic services including individual, group, family, and couples therapy, in addition to specialized services such as anger management groups and preventative education programs. Individuals and families who are struggling financially may qualify for services at a reduced fee. Most insurance is accepted, including Medicare Part B and Medicaid.

Nearly twenty years ago, Lisa first sought help from Catholic Charities, Diocese of Joliet. She was recently divorced, struggling with multiple sclerosis, and her young son was showing signs of anger. Determined to help her son and improve their lives, Lisa began seeing a Catholic Charities counselor.

"I wasn't taking care of myself before that point," Lisa admitted. "I was 100% focused on my son and my home." So, Lisa began the hard work to slowly rebuild, with guidance from her counselor. As Lisa has evolved and changed over the years, she continues to participate in counseling because she finds it such an important tool along the journey of her life. Her hard work has been very rewarding. "Eventually, I became my own person again," she revealed.

Today, Lisa works two jobs that she enjoys and has an active social life. Her M.S. will always be a factor that impacts her life, but Lisa is coping with it well. She believes that her counseling sessions have made a huge difference and continues to participate in counseling regularly.

"Lisa is a wonderful woman," her counselor said. "As therapists, we help each client recognize his/her own qualities of greatness and, hopefully, empower them to move forward on their emotional journey with hope and strength." Lisa now recognizes and utilizes her personal strengths as a catalyst for change.

Lisa feels fortunate to have the support of her Catholic Charities counselor. "If it wasn't for Catholic Charities, I wouldn't be where I am today."

ALTERNATIVE HOUSING PROGRAMS

DuPage, Ford, Grundy, Iroquois, Kankakee, Kendall & Will Counties—Providing housing programs for individuals and families who are homeless or at-risk, including transitional housing, permanent supportive housing and more.

HOPE HOUSE DuPage County—Providing housing and supportive services to individuals and families who are homeless due to divorce, job loss or depleted savings. During a temporary, short stay, participants work toward securing employment and permanent housing. Hope House also provides the 24-hour crisis hotline to assist in the single point of entry process.


EMERGENCY SERVICES & HOMELESSNESS PREVENTION

Will, Grundy, Kendall, DuPage, Kankakee, Ford & Iroquois Counties—Providing food and travel vouchers; clothing and furniture vouchers; financial assistance for prescriptions; rent/mortgage assistance, and information/referral to other community resources.

SUPPORTIVE SERVICES FOR

VETERAN FAMILIES DuPage, Grundy, Iroquois, Kankakee, Kendall & Will Counties—Assisting veterans who are homeless or at risk of homelessness. Services include case management; employment and education assistance; locating housing, and helping pay rent arrearages or security deposits. Each program participant is linked with the US Department of Veteran Affairs to gauge eligibility for additional VA benefits and services.


DAYBREAK CENTER Will, Grundy & Kendall Counties—Year-round emergency shelter 24 hours a day. The program provides professional case management and wraparound services such as employment programs promoting self-sufficiency. Shepherd's Table feeding all members of the community who are hungry and unable to provide for themselves by offering a free mid-day meal. Shepherd's Table is also used as a warming and cooling center.



John, 62 years old, is well-recognized around Joliet. Known as the "can man," John spends his time walking through town, picking up cans, and taking them to a junkyard to exchange for money. This kind man has formed friendly relationships with countless people over the years and many of them save their cans to give him. "Everyone in town knows me," he says. "Doctors, lawyers... everyone." This great-grandfather lived for many years in an encampment in Joliet known as "tent city." Tent city refers to an unauthorized settlement of homeless individuals who live in tents. John felt safe living in tent city because he had formed friendships with the other individuals who lived there and knew that they would watch out for him and his belongings. When the weather became very cold, John would walk to Catholic Charities' Daybreak Center to stay in the emergency shelter until the weather got a bit warmer.

He continued this cycle for five years – only staying at Daybreak when the weather became unbearable. Over the years, staff at Daybreak Center encouraged John to allow them to help him obtain permanent housing, but he wasn't ready. He preferred to live in tent city until one day he finally approached a shelter case manager at Daybreak Center, and said, "I'm getting old and tired." He was ready to move into a more permanent housing situation.

Today, thanks to help from Catholic Charities, John has new glasses, a much-needed hearing aid, and now receives the benefits he's qualified to receive, more importantly, he has an apartment. Although he still enjoys collecting cans, John loves coming home each night to his comfortable and safe apartment.





Early Childhood Services

EARLY CHILDHOOD SERVICES

Will County

These programs include Head Start, Early Head Start, wraparound child care, Home-Based, and Expectant Mothers Initiative. Children participate in developmentally appropriate activities; receive medical and dental care; enjoy healthy meals and snacks, and appreciate playing indoors and outdoors in a safe center-based setting. Home-Based provides weekly home visits with an age appropriate educational focus for parent and child. Children with disabilities and differing abilities are encouraged to participate in an inclusive setting.

David is a young student in Catholic Charities' Early Head Start Program. His mother, Rosa, is a single parent who had experienced a year of unemployment. She enrolled David in Head Start when she started working again and is grateful for the childcare and wonderful education David receives - something she would not otherwise be able to provide – she reports that she cannot afford private daycare. Catholic Charities has helped this family in other ways, including providing vital baby supplies to David's family, including diapers, wipes, baby food, and formula when money was tight. Rosa would like to go back to college to pursue training in medical billing and obtain a degree. She began taking classes a few years ago, but was unable able to finish. Domestic violence issues in the family's history impacted her ability to work and return to school. Additionally, the family has had health concerns and hasn't had access to reliable transportation. All of these challenges have made it difficult to maintain employment and get ahead financially. However, Rosa now has a job and is saving money to buy a car. Then, she plans to catch up on her bills before returning to school. The future looks bright for little David and his mom.






