Kathleen Langdon was appointed new Executive Director of Catholic Charities, Diocese of Joliet. During her nine years with the Agency, Ms. Langdon served as Director of Development and Communications and Interim Executive Director.



Our Disaster Relief Team responded to serious flooding in Gibson City (Ford County) by providing help on-site to those impacted.

The Agency's Early Childhood Services Division partnered with Joliet Junior College to provide Early Childhood Services on campus. Rockdale Center includes two classrooms, office space, a small kitchen prep area, an outdoor playground, restrooms, and storage.

Hosted three Back to School Fairs to provide backpacks and school supplies for children from low-income households in DuPage, Will, Kankakee, and Iroquois Counties.



The Alfred Bersted Foundation awarded the Agency with \$15,000 for Emergency Services and Homeless Prevention in DuPage County.

The Pulte Family Foundation awarded Daybreak Center \$15,000.

The City of Joliet CDBG awarded the Agency \$185,000 to replace the roof and renovate the men's dorm bathroom at Daybreak Center.

The Agency raised \$45,195 on Giving Tuesday.

The Agency named the 2021 Employee of the Year, Ryan Johnson. Ryan is a senior site supervisor at Felman Center in our Head Start Program.



The Aging and Disability Services Division launched a Community Dining Program in Kankakee County.

The Aging and Disability Services Division began providing Home Delivered Meals Nutrition Services for Kankakee County, funded by AgeGuide Northeastern Illinois. This program brings home-delivered nutrition to eligible older adults in Kankakee County.

The annual Undy Sunday collection drive provided underwear, socks, diapers, and other basic needs items to Catholic Charities' clients with the help of 50 parishes, schools, and other local organizations.



The Blowitz-Ridgeway Foundation awarded the Agency with \$10,000 for Transitional Housing and Tenant-Based Rental Assistance in DuPage County.

The Community Foundation of Will County awarded Daybreak Center with \$15,000 to replace ceiling tiles.

The Agency received the 2021 Program Standout Award from AgeGuide for outstanding work done by Aging and Disability Resource Network, Adult Protective Services, Long Term Care Ombudsman Program, Senior Health Insurance Program, Telephone Reassurance Program, Healthy Aging Programs, and Care-giver Support Programs.



The Community Memorial Foundation of DuPage County awarded the Agency \$10,000 to support basic needs and emergency shelter for low-income DuPage County residents.

The Dan Gibbons Turkey Trot Foundation presented a check for \$15,000, a generous portion of the funds

raised at the annual Dan Gibbons Turkey Trot in Elmhurst.



Crane Composites presented a check from the "Crane Fund for Widows and Children" to Catholic Charities for \$2,000 to

help fund Mobile Food Pantries.



On February 12th, the Agency participated in the First Look for Charity fundraiser at the Chicago Auto Show.

Several Aging and Disability Services began offering several programs in Will County funded by AgeGuide Northeastern IL: Aging and Disability Resource Network Services (ADRN), Senior Health Insurance Program (SHIP), Community Based Programming, and Telephone Reassurance Program Services.

Wintrust financial awarded the Agency \$20,000 to support Daybreak Center, Kathy Paulsen Hope House, Back to School Fairs, and the Mobile Food Pantry Program.

Community Foundation of Kankakee River Valley awarded the Agency with \$7,000 for BTSF.

The Foster Grandparent Program was awarded the LaSalle Medallion from Lewis University.

DuPage Foundation awarded the Agency \$25,000 to support Emergency Services and Homeless Prevention.

The Community Foundation of Grundy County Young Philanthropists awarded funding to Daybreak Center and sponsored a Mobile Food Pantry.

The Agency raised \$8,125 during "Giving DuPage Days" to help fund our Transitional Housing Program for homeless families in DuPage County.

AgeGuide awarded the Agency \$70,000 to support providing counseling services to older adults.

The City of Kankakee awarded the Agency \$20,000 to support Community Services.

Duly Health and Care awarded the Agency \$15,000 to support Daybreak Center.

The Agency was awarded DuPage Community Transformation Immediate Intervention grants. Counseling Services received \$60,000 and Emergency Services received \$163,700.

United Way of the Kankakee River Valley awarded the Agency with \$4,595 for the Kankakee Back to School Fair, \$3,300 for Transitional Housing, and \$3,330 for Homeless Prevention Services.

United Way of Will County awarded the Agency \$36,800 for Emergency Services and Homeless Prevention Services, \$34,200 for Daybreak Center, and \$6,500 to support our Mobile Food Pantry Program.

United Way of Metro Chicago awarded the Agency \$150,000 in support of basic needs and housing in DuPage County.

The Wheaton Franciscan Sisters awarded \$71,380 to Catholic Charities' Immigrant Support Program and \$200,000 to Daybreak Center.

The George Eisenberg Foundation awarded the Agency \$15,000 for Permanent Supportive and Transitional Housing in DuPage County.

Community Services

Alternative Housing Programs

DuPage, Ford, Grundy, Iroquois, Kankakee, Kendall, and Will Counties

Providing a variety of housing programs for individuals and families who are homeless, including transitional housing, permanent supportive housing, rapid re-housing, and more. These programs are designed to help families build self-sufficiency.

Kathy Paulsen Hope House

DuPage County

Providing housing and supportive services to individuals and families who are homeless often due to divorce, job loss, or depleted savings. During a temporary, short stay, participants work toward securing employment and permanent housing. The Kathy Paulsen Hope House also provides the only 24-hour crisis hotline to assist in the single point of entry process for the homeless services continuum in DuPage County.

Emergency Services and Homelessness Prevention

Will, Grundy, Kendall, DuPage, Kankakee, Ford, and Iroquois Counties

Emergency Services not provided in Kankakee, Ford, and Iroquois Counties.

Providing food, clothing, furniture and transportation vouchers, financial assistance for prescriptions, rent/mortgage assistance, and information/referral to other community resources.

Supportive Services for Veteran Families

DuPage, Grundy, Iroquois, Kankakee, Kendall, and Will Counties

Assisting veterans who are homeless or at risk of homelessness. Available services include case management, employment and education assistance, locating housing, and helping pay rent arrearages or security deposits. Each program participant is linked with the US Department of Veterans Affairs to gauge eligibility for additional VA benefits and services.

Daybreak Center

Will, Grundy, and Kendall Counties

Shelter

Providing year-round emergency shelter 24 hours a day. The program also provides professional case management and wraparound services, such as employment programs, that promote self-sufficiency.

Shepherd's Table

Feeding all members of the community who are hungry and unable to provide for themselves by offering a free mid-day meal. Shepherd's Table is also used as a warming and cooling center during extreme weather.

Immigrant Support Program

DuPage, Ford, Grundy, Iroquois, Kankakee, Kendall and Will Counties

Provides advocacy, support, and community outreach for individuals who need emergency services and immigration related support.



Jack, 29, and Dee, 33, have struggled with homelessness for many years. This couple has many challenges that create barriers to self-sufficiency. They have struggled with substance use disorder, mental health concerns, and developmental disabilities. Dee has always maintained stable employment but needed to quit her job when she experienced complications with her pregnancy last year. With their deep love for their son, this hard-working couple was more motivated than ever to stabilize their situation but wasn't sure where to begin. Catholic Charities helped Jack apply for disability. Then, the Agency assisted the family with rent on their one-bedroom apartment. Now, this family has a safe and stable home to raise their sweet son.

Counseling

Counseling Services

Will, Grundy, Kendall, DuPage, Kankakee, Ford, & Iroquois Counties

Providing healing and hope through caring and effective behavioral health services. The diverse and professional therapists provide a wide range of therapeutic services, including individual, group, family, and couples therapy, in addition to specialized services such as anger management groups and preventative education programs. Individuals and families who are struggling financially may qualify for services at a reduced fee. Most insurance is accepted, including Medicare Part B and Medicaid.



Latonya and her three teenage children have endured significant challenges over the past ten years. When the children were young, Latonya made the difficult decision to separate from her husband. He had struggled with substance use disorder throughout most of their marriage. Home life had become chaotic and Latonya had reached a point where she didn't think she could keep her children safe in an environment where her husband was experiencing active addiction. Focused on creating a household free from the cycles of addiction, Latonya left her husband. Over the years, the children have struggled with the changes in the family dynamic and estrangement from their father. Latonya has had a difficult time financially supporting the household. As the children grew into their teenage years, they each began to experience mental health concerns, including anxiety and depression. Latonya started seeing a Catholic Charities therapist to process her trauma and learn how to best help her children through their difficulties. As a single parent, Latonya said it's hard to "be the mom and the dad" to her children. Catholic Charities' sliding scale fees made it possible for Latonya to afford therapy, which has helped her make healthy changes in her family. She is eternally grateful for this support and prioritizes her weekly appointments in her busy schedule.

Early Childhood Services

Early Childhood Services

Will County

These programs include Head Start, Early Head Start, Home-Based programs, Expectant Mothers Initiative, and wraparound childcare services. Children participate in developmentally appropriate activities, receive medical and dental care, enjoy healthy meals and snacks, and appreciate playing indoors and outdoors in a safe, center-based setting. Home-Based Programs provides weekly home visits with an age appropriate educational focus for parent and child. Children with disabilities and differing abilities are encouraged to participate in an inclusive setting. Expectant mothers receive prenatal and post-partum education and assistance in preparing the home for baby's arrival. Counseling and other mental health services are provided as needed to children and families. Family engagement is encouraged and supported. Family advocates work directly with families to provide supportive services, such as financial planning and goal setting, and assist in securing resources for job searches, continued education, and ESL classes or GED classes to help families become self-sufficient.



In the early days of the COVID-19 pandemic, Ingrid discovered she was expecting a baby. The 19-year-old was excited but also scared. When her boyfriend violently assaulted her when she was in her first trimester, Ingrid knew that she had to find a way to leave. She believed that he might kill her and the baby if she stayed. Without anywhere to go or family support, Ingrid packed a bag and left her home behind. She had no support system and spent the next two months homeless. When Ingrid's daughter was born, she was over the moon.

This dedicated mother was eager for her daughter to experience a positive early childhood educational experience and enrolled her in Catholic Charities' Early Head Start Program. Ingrid's daughter is thriving in the program, and the childcare has given Ingrid the opportunity to start working to support her family. After a few years of heartbreak and challenges, this small family is heading in a positive direction and excited for their future.

Aging & Disability Services

Senior Companion Program

Will, Grundy, Kankakee, & Iroquois Counties

Offering adults age 55 and older the opportunity to support and interact with homebound peers through regularly scheduled home visits.

Care Coordination

Kankakee County

Offering frail, older adults and families assistance in assessing the need for care and coordinating an overall plan of service to maximize the older person's independence in the home.

Adult Protective Services

Kankakee & Grundy Counties

Providing trained and caring professionals to help determine the services most needed to stop neglect and abuse, protect the person who has suffered abuse or neglect, and assist the individual in the healing process. Intervention for the abuser is also offered.

Foster Grandparent Program

Will County

Offering adults age 55 and older an opportunity to work with children at local elementary schools and pre-schools.

Information and Assistance

Kankakee County

Providing information about, and linkage to, the many services and benefits available to older adults and persons with disabilities.

Money Management Program

Kankakee, Grundy, Iroquois, & Will Counties

Offering adults the opportunity to serve and advocate for low-income older adults who have difficulty budgeting, paying routine bills, and keeping track of financial matters.

Long-Term Care Ombudsman Program

Grundy, Kankakee, & Will Counties

Volunteers provide advocacy and support for residents in long-term care facilities, acting at the direction of the resident to resolve his/her concerns or complaints.

Telephone Reassurance Program

Grundy & Kankakee Counties

Volunteers make friendly phone calls to older adults who are isolated, reside alone, or just need encouragement or reminders throughout the day.



Earl, 60, is homebound and living on an extremely low income. With a long list of health conditions, Earl spends most of his day confined to a recliner in his home. He is also in chronic pain from several of his health challenges. Even the smallest luxuries are out of reach – like a simple coffee pot to make a cup of coffee in the morning. It's very isolating and can feel depressing, particularly without family support.

Recently, Earl began receiving visits from a Catholic Charities Senior Companion. This is his first opportunity to socialize since becoming homebound. His Senior Companion comes to his home each week to chat and play games. It's the brightest spot in Earl's week and he looks forward to it. Simply connecting with another person can make such a powerful difference in the life of someone who is otherwise completely alone.

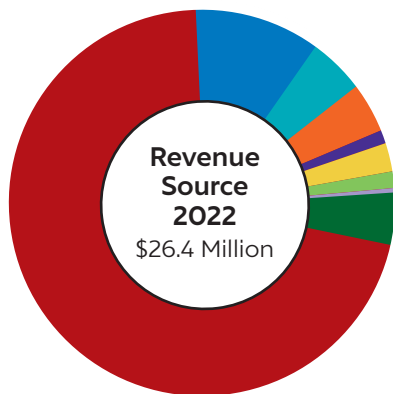

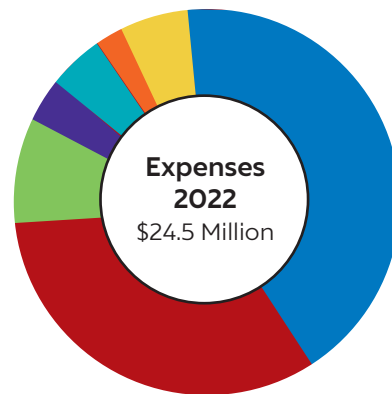
