- The August Appeal, in honor of Catholic Charities' Month, raised \$191,785.
- The Agency received an Immediate Intervention Grant for \$223,700 (\$60,000 for our Counseling Program and \$163,700 for Emergency Services/Homeless Prevention) in DuPage County. This support was provided by the DuPage County Transformation Partnership, a collaboration between DuPage County and DuPage Foundation.
- Held *A Swing and a Prayer* golf outing for the first time post-COVID at Cog Hill Golf and Country Club. The Presenting Sponsor was Hollywood Casino Joliet.
- The Agency's Kankakee office moved into a new facility at 100 College Drive, on the campus of Kankakee Community College.
- The Agency's Aging and Disability Services Division hosted two Senior Expos – one in Kankakee and one in Joliet.



- Hosted three Back to School Fairs to provide backpacks and school supplies for children from low-income households in DuPage, Will, Kankakee, and Iroquois Counties.
- The Alfred Bersted Foundation awarded the Agency with \$15,000 for Emergency Services and Homeless Prevention in DuPage County.
- The Pulte Family Foundation awarded Daybreak Center \$15,000.
- The City of Joliet CDBG awarded the Agency \$195,000 to renovate the bathroom in the men's dorm at Daybreak Center.

- The Agency officially celebrated 60 years of being incorporated into the Diocese of Joliet with a gala on October 8 at the Blanchette Catholic Center.
- The Agency's DuPage County office moved to a new location at The Agency's Aging & Disability Services Division received two awards from AgeGuide Northeastern Illinois: one for Grant Stewardship and another for finding creative ways to serve older adults.
- Several Agency programs received Community Impact funding from the United Way of Kankakee and Iroquois Counties for our Back to School Fair, Horizons Joint Transitional Housing, Homeless Prevention, Money Management Program, Long Term Care Ombudsman Program, Healthy Aging Community Based Programing, and Home Delivered Meals.
- The Agency raised \$38,275 on Giving Tuesday.
- Leanne Gregoire, Director of Aging and Disability Services South, was awarded the 2022 Employee of the Year award.

- The All Souls' Day Appeal raised \$143,545.



- The annual Undy Sunday collection drive provided underwear, socks, diapers, and other basic needs items to Catholic Charities' clients with the help of 50 parishes, schools, and other local organizations.

- The Blowitz-Ridgeway Foundation awarded the Agency with \$10,000 for Transitional Housing and Tenant-Based Rental Assistance in DuPage County.
- The Community Memorial Foundation of DuPage County awarded the Agency \$24,000 to support basic needs and emergency services for low-income DuPage County residents.

- The Agency hosted a hospitality suite on February 14 at First Look for Charity at the Chicago Auto Show.

- The Agency hosted its inaugural 5k run/walk in Kankakee County called Glazin' the Trail on the campus of Kankakee Community College.



- Community Foundation of Kankakee River Valley awarded the Agency with \$7,000 for BTSF.



- DuPage Foundation awarded the Agency \$20,000 to support Emergency Services and Homeless Prevention.



- The Gardner-South Wilmington Township High School District 73 Young Philanthropy Group awarded a \$1,200 grant to our Mobile Food Pantry Program.
- The Agency received a check from the "Crane Fund for Widows and Children" for \$3,000 to help fund Mobile Food Pantries.

- Duly Health and Care awarded the Agency \$15,000 to support Daybreak Center.
- United Way of Will County awarded the Agency \$40,000 for Emergency Services and Homeless Prevention Services, and \$40,000 for Daybreak Center.

- United Way of Metro Chicago awarded the Agency \$50,000 in support of basic needs and housing in DuPage County.
- The George Eisenberg Foundation awarded the Agency \$5,000 for Permanent Supportive in DuPage County.

## Community Services

### Emergency Services and Homelessness Prevention

*DuPage, Grundy, Kankakee, Ford, Iroquois & Will Counties*

Providing food and travel vouchers; furniture vouchers; financial assistance for prescriptions; rent/mortgage assistance; and information/referral to other community resources.

### Daybreak Center

*Will, Grundy & Kendall Counties*

#### Shelter

Providing year-round emergency shelter 24 hours a day. The program also provides additional services that promote self-sufficiency.

#### Shepherd's Table

Feeding members of the community who are hungry and unable to afford food by offering a free mid-day meal. Shepherd's Table is also a warming and cooling center during extreme weather.

### Kathy Paulsen Hope House

*DuPage County*

Providing housing and supportive services to individuals and families who are homeless often due to divorce, job loss or depleted savings. During a short stay, participants work toward securing employment and permanent housing. Kathy Paulsen Hope House also provides a 24-hour crisis hotline to assist in the Coordinated Entry process for the homeless services in DuPage County.

### Alternative Housing Programs

*DuPage, Ford, Grundy, Iroquois, Kankakee, Kendall & Will Counties*

Providing a variety of housing programs for individuals and families who are homeless or at-risk, including transitional housing, permanent supportive housing and more. These programs are designed to maximize a family's self-sufficiency.

## Early Childhood Services

### Early Childhood Services

*Will County*

Providing Head Start, Early Head Start, wrap-around child care, Home-Based, Expectant Mothers Initiative, and Doula Program. Children participate in developmentally appropriate activities; receive medical and dental care; eat healthy meals and snacks; and enjoy playing indoors and outdoors in a safe center-based setting. Home-Based provides weekly home visits with an age-appropriate educational focus for parents and children. Children with disabilities and differing abilities are encouraged to participate in an inclusive setting. Expectant

Mothers receive prenatal and postpartum education and assistance to prepare for baby's arrival. Counseling and other mental health services are provided as-needed to children and families. Family engagement is encouraged and supported. Family Advocates work directly with families to provide supportive services like financial planning and goal setting. Assistance with accessing resources such as job searches, continued education, and ESL or GED for families to become self-sufficient is also provided.

# Aging & Disability Services

## Senior Companion Program

*Will, Grundy, Kankakee, & Iroquois Counties*

Offers adults age 55 and older the opportunity to support and interact with their homebound frail peers through regularly scheduled home visits.

## Foster Grandparent Program

*Will County*

Offers adults age 55 and older the opportunity to work with children with special needs at local elementary schools and preschools.

## Money Management Program

*Kankakee, Grundy, Iroquois, & Will Counties*

Offers adults the opportunity to serve and advocate for low-income older adults who have difficulty budgeting, paying routine bills and keeping track of financial matters.

## Information and Assistance

*Kankakee County*

Provides information about and linkage to the many services and benefits available to older adults and persons with disabilities.

## Care Coordination

*Kankakee County*

Offers frail older adults and their families assistance as they assess the need for care and coordinate an overall plan of service to maximize the older person's independence in the home.

## Long-Term Care Ombudsman Program

*Grundy, Kankakee, & Will Counties*

Provides advocacy and support for residents of long-term care facilities. Provides education about resident rights and related information to residents, community members, long-term care facility staff, and legislative representatives. Acts at the direction of the resident to resolve their concerns or complaints.

## Adult Protective Services

*Kankakee & Grundy Counties*

Provides trained and caring professionals to help determine the services most needed to stop neglect and abuse, protect the person who has suffered abuse and/or neglect and assist the individual in the healing process. Intervention for the abuser is also provided.

# Counseling

## Counseling Services

*Will, Grundy, Kendall, DuPage, Kankakee, Ford, & Iroquois Counties*

Providing healing and hope through caring and effective behavioral health services. The diverse and professional therapists provide a wide range of therapeutic services, including individual, group, family, and couples therapy, in addition to specialized services such as anger management

groups and preventative education programs. Individuals and families who are struggling financially may qualify for services at a reduced fee. Most insurance is accepted, including Medicare Part B and Medicaid.






